is an **American 501(c)(3) public charity** (EIN 13-3966503), which since 2000 has enabled American donors to support projects of general interest in France and abroad, while benefiting from the tax deduction in force in the USA.

teps

- 1. Prepare your application, with the support of Fondation de France's international team, for examination and approval by our authorities.
- Once your project has been validated, your donors make their donations to Friends of
 Fondation de France, indicating your organization as beneficiary. Friends of Fondation de
 France issues a tax receipt for the donors in accordance with the US law.
- 3. Friends of Fondation de France transfers the funds to Fondation de France after deduction of the administrative costs, which transfers in turn to your organization.
- 4. Within one year of the date of payment of the funds, your organization will be asked to send a report on the use of the funds.
